Just a note about donations, you may not know...

Only Ontario residents are allowed to donate to a political party registered in Ontario.

All Ontarians can receive a generous tax credit when they donate to the Green Party of Ontario and/or its Parry Sound-Muskoka Constituency Association. Provincial political tax credits are not a deduction against your income, but **a real credit against your payable tax and will be added to your refund if no payment is owed.**

Ontarians may donate a total amount of up to \$1,650 to any combination of local riding associations. They may also donate a separate amount of up to \$1650 to a political party.

If donating in CASH, the maximum allowed is \$25.

Your tax credit is based upon how much you donate:

- 75% on the first \$427 donated
- 50% on the portion of your donation between \$427 and \$1,423
- 33.33% on the portion between \$1,423 and \$3,238
