Just a note about donations, you may not know...

Only Ontario residents are allowed to donate to a political party registered in Ontario.

All Ontarians can receive a generous tax credit when they donate to the Green Party of Ontario and/or its Parry Sound-Muskoka Constituency Association. Provincial political tax credits are not a deduction against your income, but **a real credit against your payable tax and will be added to your refund if no payment is owed.**

Ontarians may donate a total amount of up to \$3,325 to any combination of local riding associations.

If donating in CASH, the maximum allowed is \$25.

Your tax credit is based upon how much you donate:

- 75% on the first \$437 donated
- 50% on the portion of your donation between \$437 and \$1,457
- 33.33% on the portion between \$1,457 and \$3,315.

Tax Tip: If a family wants to donate in excess of \$437, consider splitting the donation into portions which are less than \$437.

For example: A donation of \$800, from an individual provides a \$505.75 tax credit. Two donations of \$400 each, provides a \$300 tax benefit per person, or a total combined tax benefit of \$600.
