## Just a note about donations, you may not know...

Only Ontario residents are allowed to donate to a political party registered in Ontario.

All Ontarians can receive a generous tax credit when they donate to the Green Party of Ontario and/or its Parry Sound-Muskoka Constituency Association. Provincial political tax credits are not a deduction against your income, but a real credit against your payable tax and will be added to your refund if no payment is owed.

Ontarians may donate a total amount of up to \$3,375 to any combination of local riding associations, plus the same amount to a political party.

If donating in CASH, the maximum allowed is \$25.

Your tax credit is based upon how much you donate:

- 75% on the first \$486.62 donated
- 50% on the portion of your donation between \$486.62 and \$1,622.08
- 33.33% on the portion between \$1,622.08 and \$3,690.42

*Tax Tip*: If a family wants to donate more than \$486.62, consider splitting the donation into portions which are less than \$486.62.

For example: A donation of \$800, from an individual provides a \$521.66 tax credit. Two donations of \$400 each, provides a \$300 tax benefit per person, or a total combined tax benefit of \$600.
